## EVM Europe Initiative Maintains Momentum

The EVM Europe initiative continues to progress with a successful third EVM Europe 2012 Conference held at "the Escuela Técnica Superior de Ingeniería de Edificación, part of the Universitat Politècnica de València" (the School of Building Engineering at the Polytechnic University of Valencia, Spain) on 23–24 November 2011. València is a historic Spanish city located on the Mediterranean coast first founded as a Roman colony in 138 BC. The historic center is a large 169 acres in size and the city is also known for many monuments including the landmark City of Arts and Sciences, an avant-garde and futuristic museum complex.

The welcome address was from Mr. Rafael Sánchez, Director of the School of Building Engineering, Polytechnic University of Valencia, Spain.

The keynote presentation was by Mr. Jim Malkin, the Director of the Program Management Office at General Dynamics European Land Systems (GD ELS) and by David Robles who is currently PMO Manager of the SV Programme at GD ELS.

This presentation, identified by the EVM Europe initiative, has publicised another large scale European EVM implementation which covers 14 sites in 6 countries. The challenges and complexities of an international organisational EVM implementation which includes multiple languages and requirements to conform to multiple EVM standards including the US ANSI EAI 748B and Australian AS 4817 standards was also discussed in this informative presentation. It was noted that all managers responsible for EVM are Europeans.

The Conference continued the unique focus for EVM Conferences on research with a short presentation by Prof. Dr. Mario Vanhoucke from Ghent University, Belgium on the recently awarded €1 million (plus) project controls/EVM research project which is planned to execute over a 6 year period. Masters students from Ghent University presented their EVM related research findings as has occurred at previous European Conferences. A strategy to consider for re-
